1.1 The Chairman, Mr Neville Clarence, welcomed all persons attending the Annual General Meeting.

3. <u>CONFIRMATION OF THE MINUTES OF THE PREVIOUS ANNUAL GENERAL</u> <u>MEETING DATED 21ST MARCH 2018</u>

3.1 There being no matters arising were proposed by Chris Beale from Easterns and seconded by Paul Harley from Zimbabwe.

4. <u>PRESIDENT'S REPORT</u>

- 4.1 On behalf of all the SA Masters Waterpolo players, Neville Clarence extended their sincere condolences to the family and friends of players who had passed away since the last AGM namely:

- 4.2 Neville Clarence read out his report copy attached to minutes.
- 4.3 There being no matters arising it was proposed by Chris Beale from Easterns and seconded by Brett Redelinghuys from Western Province.

5. TREASURER'S REPORT

- 5.1 Copies distributed via email as well as attached to minutes.
- 5.2 Neville Clarence presented the treasurer's report.
- 5.3 Salient points from the treasurer's report:
 - Revenue from Durban in 2016
 - An amount of R 16,400 has been recovered from the debt of R 18,750.
 - The final outstanding amount of R 2,350 was written off.
 - 2020 Subs will remain unchanged at R50/player.
 - Costumes
 - With the number of players reaching their attendance milestones, it anticipated that the future costs of costumes will increase.
- There being no other queries arising from the financials, acceptance was proposed by Gregg Higgs of Natal and seconded by Antonio Lopes of Central Gauteng.

7. SOUTH AFRICAN MASTERS WATER POLO CHAMPIONSHIPS 2020

7.1 Currently with Western Province (Stellenbosch) for another year.

8. <u>SELECTION OF A DISCIPLINARY COMMITTEE</u>

- 8.1 For any disciplinary hearing required at the tournament, the following will be required to be present:
 - Tournament directors
 - Referees involved in the game
 - Chairman of SAMWP
- 8.2 Provinces to provide suitably qualified referees to assist if called upon.

9. <u>GENERAL</u>

- 9.1 <u>Under age team entries</u>
- 9.1.1 There is only a 5% conversion rate from school players to club players.
- 9.1.2 Masters should encourage the younger players to experience the "gees" and camaraderie of the event to allow for them to remain with the game and not give up playing waterpolo.
- 9.1.3 A new Open section was mooted to cater for the above.
- 9.1.4 A vote for a sub-30 section (Open with no handicapping and no restriction on national players)
 - In favour = five (5)
 - Against = three (3)
 - Motion carried for 2020.
- 9.1.5 Age groupings for 2020:
 - Open
 - 30+
 - 40+
 - 50+

Notes to the above:

- o Based on the number of teams entering for 2020, a decision would be made to spilt the oversubscribed teams into five (5) year brackets.
- o Based on the 2019 entries this would be applicable to the 50+ section which would result in the following:
 - **■** 50+
 - **55**+
- o A 60+ section could be considered in a few years' time once critical mass has been achieved in this age bracket to warrant this section being created.

- 9.1.6 The Local Organising Committee (LOC) to be cognisant of the potential increase in the number of overall tournament games and need to address accordingly noting that all teams should get at least one (1) game on the last day of the tournament.
- 9.1.7 Additional costs will be incurred to source new trophies and medals for the Open section.
- 9.1.8 Special dispensations may be applicable to teams (weaker) if they apply to SA Masters who will review and substantiate each case on their merits for inclusion into other age sections.

9.2 <u>Under aged players</u>

9.2.1 The current ruling for national players will remain in effect unless they are entered into a team which plays in the newly created Open section.

"No past or present International player shall be permitted to play, unless that player turns thirty (30) years of age in the year of the tournament."

9.3 <u>Administration</u>

- 9.3.1 The idea of changing the current administration into an Executive and a Board to run SA Masters did not carry favour other than from the proposer.
- 9.3.2 No support from the other provinces.

9.4 <u>Borrowing of players</u>

- 9.4.1 Borrowed players tend to play most of the time.
- 9.4.2 Action needs to be taken against the teams abusing this rule.
- 9.4.3 The Local Organising Committee (LOC) is required to police for these transgressions, however, they do not know all the players and it is difficult for them to effectively manage the situation.
- 9.4.4 Vote on to the abolishing of the "borrowing" rule:
 - In favour of abolishing the borrowing rule = five (5)
 - The motion carried as more than half of the delegates supported this.
 - No borrowing of players for next year (2020).

9.5 Handicapping

- 9.5.1 No handicaps would be applied to the newly created Open section.
- 9.5.2 Current handicap rule would apply to all other sections.
- 9.5.3 All were in favour of this recommendation.

9.6 <u>Timing of the tournament</u>

- 9.6.1 It was suggested the 2020 tournament revert back to the week in which the public holiday (Human Rights day) was available.
- 9.6.2 For 2019 it was the same week as the Cape EPIC cycle tour.
- 9.6.3 Stellenbosch to advise on next year's dates after consultation with the other parties.

9.7 Paul Roos pool

- 9.7.1 The distance to walk to this pool was not in favour of the older teams.
- 9.7.2 A shuttle service could be considered for next year.

10. <u>DATE OF NEXT MEETING</u>

10.1 The date of the next Annual General Meeting will be on the Wednesday night prior to the commencement of the 2020 tournament – dates to be finalised.

11.1 There being no further business to discuss the meeting closed at 19h15.
